Alabama	February 9, 2015	Gay marriage is legal.
Alaska	October 12, 2014	A federal judge issues a ruling allowing gay marriages in the state after the U.S. 9th Circuit Court of Appeals ruled the week before that same-sex marriage bans violate the rights of gay couples.
Arizona	October 17, 2014	U.S. District Court Judge John Sedwick strikes down Arizona's gay marriage ban and declines to issue a stay of his ruling. The state's attorney general directs clerks to start issuing gay-marriage licenses.
Arkansas	June 26, 2015	The U.S. Supreme Court ruled that same-sex couples have a constitutional right to marriage.
California	June 28, 2013	Same-sex marriages resume in California.
Colorado	October 6, 2014	Following the ruling by the 10th Circuit Court of Appeals, gay marriage officially becomes legal as Atty. Gen. John Suthers says that all of the state's counties must issue marriage licenses for same-sex couples.
Connecticut	October 10, 2008	High court rules gay couples can marry.
Delaware District of Columbia	July 1, 2013 March 9, 2010	Gay marriage is legal. The District of Columbia joins Connecticut, Iowa, Massachusetts, New Hampshire and Vermont as the sixth place in the nation to allow gay marriage.
Florida	January 6, 2015	Gay marriage is legal.
Georgia	June 26, 2015	The U.S. Supreme Court ruled that same-sex couples have a constitutional right to marriage.
Hawaii	November 13, 2013	Gay marriage is legal.
ldaho	October 15, 2014	County clerks begin issuing marriage licenses to same-sex couples after the U.S. 9th Circuit Court of Appeals ruled the week before that same-sex marriage bans violate the rights of gay couples.
Illinois	June 1, 2014	Gay marriage is legal.
Indiana	October 6, 2014	The U.S. Supreme Court turns down pending appeals in gay marriage cases. The decision makes same-sex marriage legal in Indiana, Oklahoma, Utah, Virginia and Wisconsin.
lowa	April 3, 2009	High court overturns ban on gay marriage. Gay marriages begin later in the month.
Kansas	June 26, 2015	The U.S. Supreme Court ruled that same-sex couples have a constitutional right to marriage.

Nevada	October 9, 2014	Nevada begins issuing marriage licenses after the U.S. 9th Circuit Court of Appeals declares same-sex marriages legal in the state.
New Hampshire	January 1, 2010	Law allowing same-sex marriage goes into effect.
New Jersey	October 21, 2013	Gay marriage is legal.
New Mexico	December 19, 2013	unions in the state.
New York	July 24, 2011	New York's law allowing same-sex marriage goes into effect.
North Carolina	October 10, 2014	A federal District Court judge rules that the state's ban on gay marriages is unconstitutional, and officials begin issuing marriage licenses.

South Carolina	November 20, 2014	In a 7-2 decision the U.S. Supreme Court denies an emergency stay of same-sey marriages. The ruling clears the way

Wyoming	October 21, 2014	Wyoming Atty. Gen. Peter Michael says the state won't appeal the U.S. District Court ruling striking down the state's bar on same-sex marriage. Same-sex couples can apply for marriage licenses.
